

Opioid Prescribing Trends in Ontario, Canada






□ Codeine □ Other Opioid ■ Hydromorphone ■ Oxycodone

Increasing Rates of Opioid Related Deaths





Emerging Evidence: Gabapentinoids

- Gabapentinoids exhibit dose-dependent CNS depression, and are increasingly coprescribed with opioids.
- Warning exists on gabapentin labels regarding risk when combined with opioids, but not pregabalin.

To examine the risk of opioid-related death among people prescribed gabapentinoids and opioids, and whether this risk differs by drug or dose.











- Nested Case-Control Study → 1,417 opioid-related deaths and 5,097 matched controls
- Main Exposure: Gabapentinoids dispensed in prior 120 days
- Secondary Exposures:
 - Overlapping gabapentinoid prescription
 - Dose-response analysis


Disentangling Prescribed from Illicit Opioids

Role of prescribed opioids in Ontario




- In 2016, what proportion of people dying from an opioid overdose had an active opioid prescription at time of death?

Considerations for the Future



- **Ongoing Monitoring** of policies/programs
 - Delisting of high strength opioid formulations
 - Canadian guidelines
 - Prescriber 'abandonment'
- Harm reduction as a means of reducing mortality risk
 with emerging illicit fentanyl analogues
- Engage in dialogue to understand needs/priorities of people with lived experience



You don't really know what you are getting. It's cut with so many different things that today you might be taking one dose and be okay and you can take the same dose later on in the day or the next day and you can overdose because that one drug that you think you are taking, it's a combination of drugs.

So it's like playing Russian roulette...
