

Cross-border trafficking of prescription oxycodone products manufactured in Canada

Introduction

- Abuse of prescription opioids is a significant public health problem in both Canada and the United States (US).
- As more restrictions are imposed on prescription opioids, access to these drugs via unconventional illicit sources is likely to be explored.
- One potential source is the diversion of products across the US-Canada borders.

Methods


- The RADARS System StreetRx.com is a publicly accessible website that collects anonymously reported street prices for prescription and illicit drugs.
- As of August 2016, US site users reporting acquisition of certain oxycodone products (listed in table) manufactured only in Canada were prompted to confirm the country in which the product was acquired.
- Reports to the US StreetRx website (through September 2018) were studied to quantify this cross-border trafficking of prescription oxycodone products manufactured in Canada and reported in the US.

Conclusions

- Acquisition of Canadian prescription oxycodone products is reported in the US
- This trade is not limited to states near the US-Canada border.

Limitations

- Data come from anonymous online reports of prescription medications that cannot be confirmed.

Results

- There were 617 reports of Canadian prescription oxycodone products to the US StreetRx Program website.
 - 508 (82%) confirmed that the selected drug was acquired in the US. 52 (8%) confirmed that the selected drug was acquired in Canada. 57 (9%) did not report the country in which the drug was acquired.
- There were 599 (97%) reports of crushable oxycodone products.
- There were 18 (3%) reports of OxyNEO, the only difficult to crush oxycodone product in our analysis.
- Reports in the US came from diverse geographic areas and were not concentrated in states bordering Canada.
 - Reports per state was highly correlated with state population (Spearman correlation coefficient = 0.82)
